#### 3. Community Matters.

## a. Public Participation Adjournment.

- The letters sent to BMBC and Eric Pickles were discussed with Councillor Barnard, and he offered to chase up the matter with Eric Pickles. It was agreed that this would be a good idea.
- With regards to the night time problems at the playingfield car park, the Clerk will forward the police's response to Cllr Barnard. He will also contact the police about the matter.
- Cllr Barnard informed the Council that the traffic order for yellow lines at Roughbirchworth Lane has been published and is under consultation. The work is likely to be done when the weather is dryer.
- The correspondence with Yorkshire Land's agent Mr Butler was discussed. The Parish Council is concerned about the offer to Penistone Town Council to have an interchange built if Yorkshire Land gets planning permission to build at the Oxspring Fields site.

#### 4a. Minutes of the Meeting held on Monday 5th January 2015, and Matters arising from them.

- The Chair **agreed** to sign the minutes as a true record after **agreement** by the Council (BT,IS). The Clerk had circulated action reports from the minutes and provided the latest update in addition. The Chair and other members reported on their actions.
- The fly tipping in the Rookery was discussed. Neighbourhood Pride has been asked to remove it.
- The location for the playarea seating has been decided. The Clerk will order the seats once the concrete bases have been done.
- The log train parts and new swing bridge have been delivered, and will be installed shortly.
- Councillor Stanley presented quotes for a new notice board to be placed in the Village Green. The price quoted for oak is £650, and for idigbo is £585. Posts will be £140. This is for a notice board of the same dimensions as the one near the school, fully varnished with a pin board. This quote was better than previous quotes obtained and it was agreed to have the idigbo wood board. Cllr Stanley will arrange and provide the Clerks details for invoicing.
- Councillor Taylor is fixing the Sheffield Road notice board and will put it back when ready.

- Cllr Walker presented a quote of £149 for a 3m Maypole. It would be a non permanent fixture that would be assembled when and where needed. Ribbons would be £32. The Clerk has spoken to the school about the idea but as the Head is off sick a decision has not been taken yet.
- Cllr Walker distributed a flagpole guide. Cllr Taylor will measure the previous pole and a decision will be taken on the size and spec of the pole to purchase.
- It was noted that the planning application for the houses at the back of Millstones has been refused.
- Any other matters would be included in later agenda items.

#### **5. Business Matters.**

## a. Neighbourhood Plan

- Councillor Walker thanked the Councillors for their help with delivering the NP brochures and for attending the public meetings. It was noted that Borough Councillors Barnard and Wilson also attended.
- Approximately 100 residents attended the meetings, there was some constructive criticism and some very positive comments.
- The NP committee are due to have a meeting with the School governors shortly.
- It was agreed to wait for the questionnaire results before holding a meeting between those that are against the plan and the PC or Planning Aid.
- It was agreed that there is nothing to be gained from having a meeting with Hunshelf and Penistone Councils at this point re Oxspring fields.
- The remaining grant is due to be received shortly.

## b. Playingfield Footpath

#### c. Titivators

- The Titivators are meeting next week to discuss current plans and projects.
- It was agreed that the Christmas tree lights can be stored in the shed.
- It was agreed to purchase the items put forward by the group from Rapid Hire.

## d. Grass Verge Sheffield Road

- A quote is still awaited from BMBC.
- The suggestion to remove the trees by BMBC to be able to do the work was declined.

## e. Playing field Car park

- The littering problems in the playingfield car park have escalated over recent weeks, and the number of cars parking there after dark has increased considerably.
- A local resident has said that they are willing to open and close the gate at night. Cllr Walker will follow this up.
- The police have stated that they will keep an eye on the situation, but that they cannot make people move on from a public carpark.
- Cllr Taylor is attending the next PACT meeting and will raise the issue, and Cllr Barnard will follow the issue up also.
