3. Public Participation

- Tracey Hughes from Healthwatch Barnsley spoke to the Council about the work her team are doing on Adult Safeguarding in Barnsley. She shared information for groups and noticeboards etc, and confirmed that she can attend local groups to talk about the issue. The Chair will speak to the Pop- In and the Drop -In groups. There is also training available through BMBC on Adult Safeguarding.
- Jim Garside spoke to the Parish Council about his building project off of Bower Hill. Planning permission was obtained a couple of years ago and work is about to start. He wanted the Parish Council to be aware of the works and access arrangements to the land in case of any queries from the public. He will be using the farmers field behind the property to store the material that he is going to be digging out of his plot to make the hole for the underground part of the new build. The project will take approx. 2 years to complete.

4. Previous meeting minutes

4a. Minutes of the Meetings held on Monday 15th May 2023, and Matters arising from them.

- The Chair **agreed** to sign the minutes as a true record after **agreement** by the Council (AW, GS).
- Following the audit report, an Equal Opportunities policy was circulated and approved.
- Damon Brown from BMBC traffic will attend the September meeting.
- It was confirmed that the Reds In the Community Van will be in Oxspring on the 24th July.
- It is confirmed that the Ramp It Up Project will be at the Village Green in Oxspring on the 29th August.
- Trees on Sheffield Road that need cutting back were reported to BMBC, these have been done since the meeting.
- A missing Island Bollard from Sheffield Road has been reported to BMBC, this has not been replaced yet.
- I Goldthorpe confirmed that he did not want to be co-opted after all. The Parish Councillors acknowledged this and thanked him for his long service.
- The issues at the Cross Lane/Back Lane crossroads and state of the road surface and line markings were discussed again. Borough Councillor Burnett stated that he would raise the issue with BMBC highways.
- Cllr Chambers confirmed that she is talking to someone who may be interested in being a Parish Councillor.

d. Allotment repairs

- The Chair and Alan Walker have put struts across the pedestrian gate opening at Clays Green allotments. This is now complete.
- Cllrs Chambers confirmed that her contact is not able to do any further work to the tap at Roughbirchworth. It was agreed to install a backboard and insulation for the existing pipe and place a box around the tap for the winter. Councillor Sedgwick will sort this repair with A Walker.

e. Titivator Update

- Litter picking has taken place.
- The Rose Garden has been weeded and mulch will be put down.
- The car park garden has been weeded and strimmed.
- TWIGS will be assisting on the 17th July at the playingfield car park garden and with hedgerow planting.
- Cllr Sedgwick requested to purchase compost for some Oak trees. This was agreed.
- Cllr Sedgwick reported that the seat in the Pinfold has a broken leg, caused by damage from the grass cutting equipment. It was agreed to replace the legs with possibly steel feet.
- Cllr Gratton-Rayson reported that the Village Green planter has still not been moved back into place following the damage from the grass cutters. This will be chased with BMBC. Borough Councillor A Burnett will raise the issue.
- Re the cutting at the playingfield, it was confirmed that it has been cut 3 times. Since the meeting BMBC have agreed to refund one cut so far. Cuts will be monitored and the Clerk will ensure that further cuts will be deducted from future invoices if the correct number are not done.

f. D-Day June 2024

- The Council discussed whether purchasing a Beacon for this event was a good idea.
- It was agreed not to pursue as there are no high points in the village.

g. Playingfield Container

- The 10ft container was placed in the field in June, near to the MUGA.
- It was agreed to purchase four shelving units.
- A thank you letter will be sent to Mr Fox for moving the container from the car park into the field.
